

**Minutes of the meeting on modalities for dissemination of COVID-19 advisory among people through SMS/ Voice Message**

Venue: Conference Hall of SRC, Rajiv Bhawan

Date: 16.03.2020, 3.00 PM

The meeting was chaired by Shri P. K. Jena, Additional Chief Secretary and Special Relief Commissioner. Among others, Joint Secretary, Health & Family Welfare Department, MD, OSMCL, Sr. DDG, Department of Telecommunication (DoT), GoI, Executive Director (T), OSDMA and senior representatives of Telecom Service Providers (BSNL, Airtel, Vodafone-Idea and Reliance Jio) took part in the meeting. The list of participants is at Annexure-A.

ACS & SRC in his address informed that keeping in view the spread of COVID-19 Virus in India and the declaration of COVID-19 as pandemic by the WHO, the Government of India as well as the State Government has notified it as a disaster under the Disaster Management Act, 2005. While the Government is taking all possible measures for containment of COVID-19, it is highly necessary to disseminate the appropriate advisory among the public. Therefore, he requested all the Telecom Service Providers (TSPs) to support the Government in prepare the dissemination of COVID-19 advisory among people through SMS/ Voice Message to be prepared by the Health and Family Welfare Department.

After discussion at length, the following decisions were taken:-

1. The Department of Health & Family Welfare will provide the COVID-19 Advisory material for dissemination among the people both in Odia and English to Sri Shyamal Kumar Das, OAS, Nodal Officer, Office of Special Relief Commissioner (Mob: 9437111705, Landline No. 0674-2534177, Email: [srcodishagov@gmail.com](mailto:srcodishagov@gmail.com)).
2. Sri Das, Nodal Officer of O/o SRC will send the material (SMS) to the Nodal officer of respective TSPs including BSNL for dissemination of the same to their customers.
3. All TSPs will disseminate the COVID-19 advisory to their customers through SMS free of any charge.
4. The message will be sent by TSPs to each of their mobile phone customers once a day. The TSPs will inform the No. of SMSs delivered to the customers to Nodal Officer O/O SRC office of SRC on daily basis for appraisal of the Government.
