ORDER

In exercise of the powers conferred under clause (a) of Section 50 read with Sub-Section 3 of Section 18 of the Disaster Management At, 2005 (Act 53 of 2005), the State Disaster Management Authority do hereby authorise the Municipal Commissioners of Bhubaneswar Municipal Corporation, Cuttack Municipal Corporation, Berhampur Municipal Corporation, Sambalpur Municipal Corporation and Rourkela Municipal Corporation to make emergency procurement of such provisions or materials as may be necessary for the containment of the COVID-19.

The following procedure shall be followed for the procurement: -

1. The Authority shall constitute a committee which will examine the urgency and the need under the provisions of the Act.
2. The Committee shall decide the items and quantity of the provisions/ materials required to be procured urgently through emergency procurement by waiver of tender process, if necessary.
3. The Committee shall assess availability of OEM/ suppliers for the said provisions/ materials and decide the supplier/ OEM for immediate supply depending on the nature/ time of requirement.
4. All provisions/ materials so procured shall be duly entered in a separate stock register and the bill/ vouchers must be kept in record.
5. Utilisation certificates along with expenditure statements certified by the Head of the Department shall be submitted to the appropriate authority.




